Claire adds that it should be handled on a case by case basis.

Lorette adds that one person should be appointed as a Regional Specialty request collector

Members are having a hard time keeping up with the pace of the meeting. Lauren is asked to slow down.

Paula asks that discussion is allowed before a motion is put forward.

Claire adds that yes, we should have some kind of governance for regional applications; however, Sudbury should be excluded from that rule.

Debra asks that shouldn't existing shows get first dibs on dates?

Myriam agrees that they should.

Paula asks for clarification as to what shows.

Debra clarifies she is referring to Sudbury and Erie Shores.

Lauren clarifies that the motion will exclude Sudbury and reminds members that we have no control over the HOLA regional either.

Margaret states that when a motion is made that excludes on regional from the rule, it is under scrutiny and she thinks it is a bad idea. She believes that Quebec needs to change their venue.

Lauren asks if there is a problem with the Sudbury show.

Claire, Kim, Bea, Linda, Maxine, Jane, Debra have no issues.

Margaret raises issue as if held same dates as another regional.

Lauren tires to clarify that it's not Sudbury that is the issue, it's a conflict of dates with another regional which would be discussed whenever a conflict comes up.

Paula adds that Sudbury has two possible dates: March and September.

Lauren states that there are no issues with Sudb<mark>ury and</mark> she believes that the club all wants some sort of governance.

Myriam stats that is there is a conflict with dates and Sudbury has priority, then Quebec will remove their request. She does not want to prevent the existing shows from happening.

Margaret feels this is not setting a consistent approach, what one has to do, so does the other.
